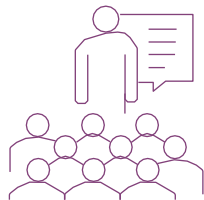
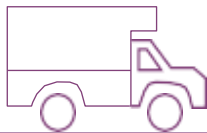

We require suppliers to submit improvement plans for non-compliant items within 10 days to get a plan reference.
